



NATIONAL COUNCIL AGAINST CHILD LABOR

Council Resolution No. 1 Series of 2022

A RESOLUTION URGING THE COUNCIL MEMBERS TO ACCELERATE THE PROVISION OF NECESSARY SERVICES TO PROFILED CHILD LABORERS

WHEREAS, Executive Order No. 92 was signed by President Rodrigo Roa Duterte on 17 September 2019 institutionalizing the National Council Against Child Labor to upscale the implementation of the Philippine Program Against Child Labor and to amplify government efforts for the protection of the rights of vulnerable sectors, especially the children, strengthen related institutional mechanisms, and establish further measures that will contribute to the prevention, reduction and elimination of any form of child labor;

WHEREAS, the child labor target under Chapter 11 of the Philippine Development Plan (PDP) 2017-2022 is “zero” to recognize child labor as a violation of human rights;

WHEREAS, one of the major strategies to achieve the child labor target under the PDP 2017-2022 and the goal of a child labor-free Philippines under the Philippine Program Against Child Labor Strategic Framework 2020-2022 is the profiling of child laborers in order to locate and identify the children who will be referred to appropriate agencies and organizations for the provision of necessary services to remove them from child labor;

WHEREAS, Section 8 of Executive Order No. 92 provides that all government agencies and instrumentalities are directed and all local government units are enjoined to extend active support and assistance to the Council to effectively implement this Order;




BE IT RESOLVED FURTHER that the Council members request the Social Service Delivery Technical Working Group to formulate plan of action to implement this Resolution.






